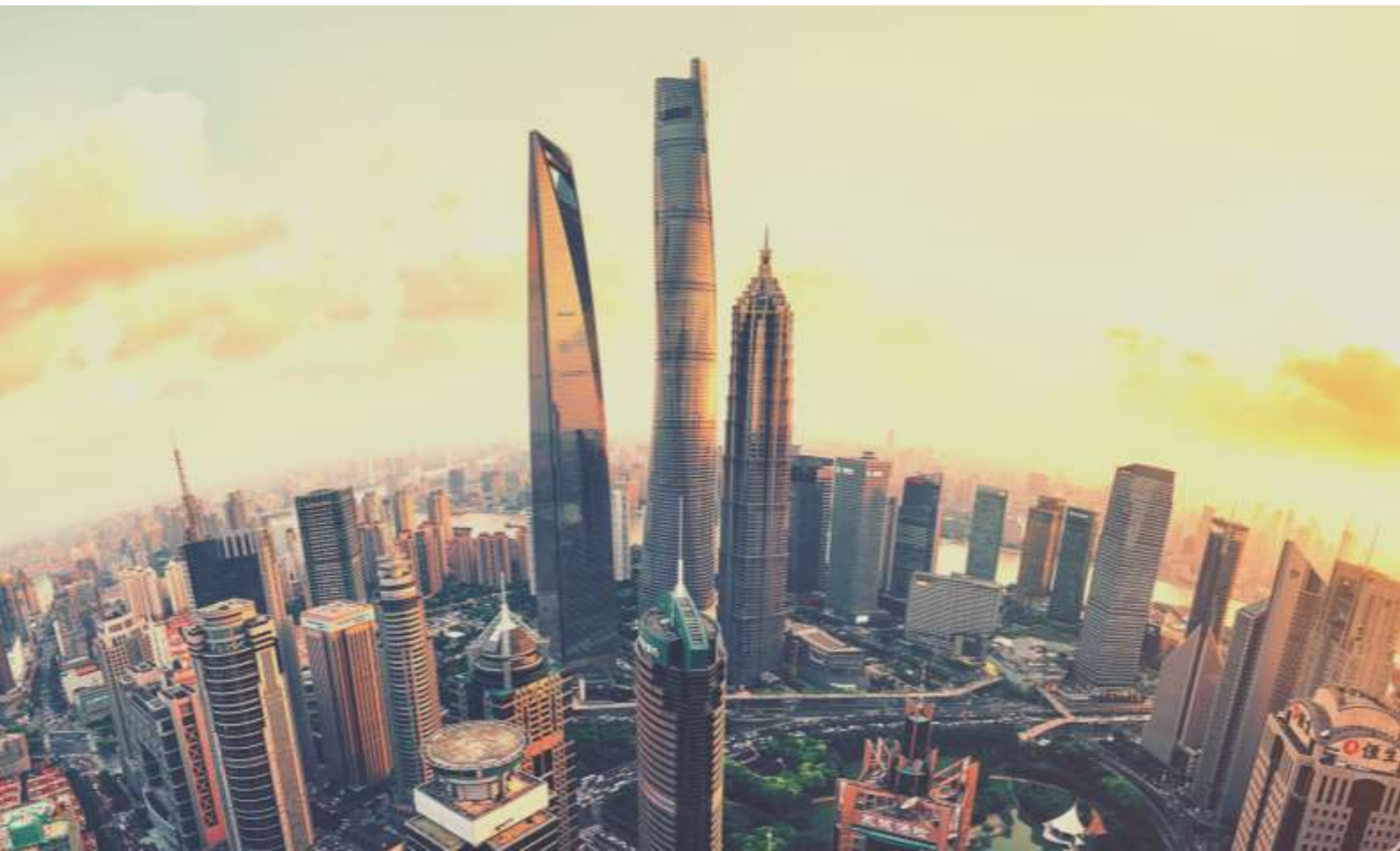

Onboarding-Assignment of a Relationship Manager

We assign a qualified professional as the Relationship Manager(RM) / Virtual CFO for the project as the single point of contact.

Execution & Co-ordination, Appraisal with CRMs

We set up the account on our CRMs and walk you through our processes. All our data is centralised and cloud based, duly protected and confidential. Our RMs are available over calls, emails and other modes of remote communication.

Review and Discussion

Once the project is ongoing, we have a system of periodic review - monthly/quarterly, based on the requirement. Monthly one detailed call is mandatorily taken up for appraisals and further calls, as required.
